#### **New Business:**

It was moved and seconded to extend the deadline for TOY entry fees to the June meeting. It was also moved and seconded to pay for the TOY trophies from the general treasury and not from the entry fees, and to revise the TOY requirements accordingly. The revised paragraph 5 of the TOY requirements is as follows. The change is noted in red.

5. Entry fees ~~collected will be used to pay for plaques or trophies for Overall and for each of the 4 meat categories (and other categories as approved). Remaining funds~~ will be distributed as follows: 50% will be awarded for Overall Winner. The remaining funds after this payout will be equally divided among the first place winners of the 4 meat categories (and other categories as approved).

Amy Forbes with Ronald McDonald House Charities Wichita made a presentation to ask the Society if they would be interested in volunteering to help cook at the Ronald McDonald House. Volunteers are needed to cook for 15-20 people while they are staying at the House because of children in the Hospital. A more definite number would be available 2 – 3 days before. All food would need to be prepared in their kitchen, although a question was asked if the food could be prepared off site with a catering license. A food handlers license is not required since the House is covered under its own license. Food could be cooked in a patio area next to the building, with any required preparation done inside the building. It was decided to let everyone think about this and discuss it again at the next meeting. The question to the membership is what and how could SCKBBQS partner with Ronald McDonald House Charities Wichita to provide either a onetime community service project and/or a continued partnership with this charity?
